4. Recess to allow County Clerk to gather Public Participation Forms.



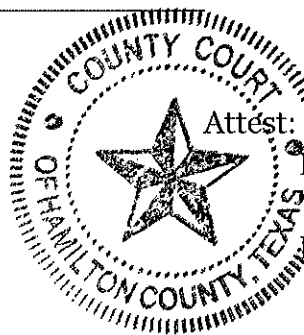


