7. Adjourn

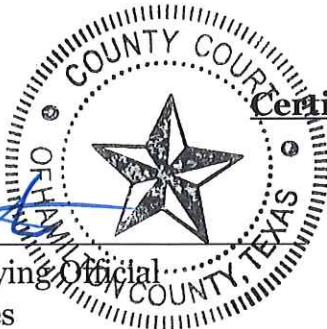
