Hamilton County Commissioner's Court met in FEMA session on Wednesday, August 13, 2025 at 9:00 A.M. with the following members present for the first session: County Judge James Yates, Commissioners Johnny Wagner, Dickie Clary, Keith Allen Curry, and David Ogle was absent. Attendees from Hamilton County Alejandra Moncada, Debbie Rudolph, and Lacy Alexander. From FEMA Nana Alconor was present. From TDEM Brittany Hammond, Brandi Masterson, and Kevin Enoch.

Dickie Clary called the meeting to order, and a quorum was established.

- ***Project 906606 will cost \$116,024.31. Projects 758248, which are the county roads in precinct one. Project 766071 is CR 101 below the bridge. Project 766102 is on Pruitt Road. These projects will be submitted Today, Tuesday, August 13, 2025.***
- ***Ms. Alconor will get in touch with Mr. Delgado to assist Commissioner Wagner on the bridge project, as the measurements do not match the quantity of the materials.***
- ***From then on, they can have follow-up calls, but meetings will not be necessary. Judge Yates thanked the team and encouraged them to use the model they used in this county in other counties.***

- ***This meeting was to discuss project 4879 on the damages that occurred in precinct 3.***
- ***October 12, 2025, will be the 60-day period to identify and report the disaster-related damages and impacts. On the damage inventory list, the first two inventories were taken out because County Road 509 and 505 are in precinct 4; however, Commissioner Clary states there are no damages, so these items were removed from the list.***

- **County Road 216 is a priority at the moment due to severe damage, including a sinkhole and surface damage, and several exposed culverts. The road is completely closed.**
- **FEMA will send a site inspector.**
- **The culverts are around 45 years old.**
- **FEMA will reimburse 75%**
- **There was a brief explanation on how big and small projects are done.**
- **A lot of questions and concerns could not be answered since Commissioner David Ogle was absent.**
- **They agreed to have a weekly meeting at the beginning of this project, and they can change it as time progresses. Wednesday at 10:00 am will be the meeting.**
