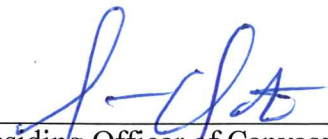

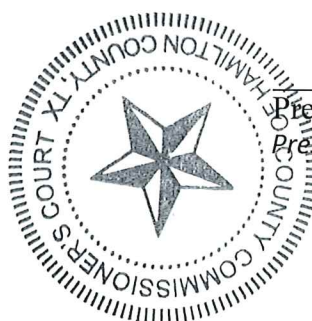

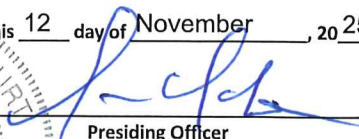


## SUMMARY OF PRECINCT RETURNS
