


**NOTICE OF MEETING

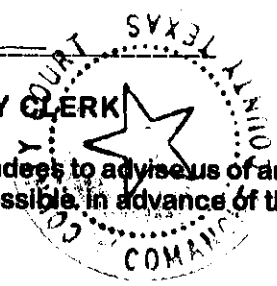
