A tax rate of \$0.278693 per \$100 valuation has been proposed by the governing body of Comanche Consolidated Hospital District.

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for Comanche Consolidated Hospital District from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that Comanche Consolidated Hospital District may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Comanche Consolidated Hospital District is not proposing to increase property taxes for the 2021 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 28, 2021 AT 6:00 pm AT Comanche County Medical Center, 10201 Hwy 16 N, Comanche, TX 76442.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Comanche Consolidated Hospital District is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of Comanche Consolidated Hospital District at their offices or by attending the public meeting mentioned above.
