## VISITATION:

1. Authorized visitors must be 17 years of age or older. Visitors under the age of 17 must be accompanied by a parent or guardian. No more than two visitors per inmate at one time.
2. Visitors must present a state approved picture ID before they will be allowed to visit. All visitors must be fully dressed, act, and behave in an orderly manner. Persons who do not conform to this rule will be dismissed from visitation.
3. All visitors must not have been incarcerated in this facility in the past 30 days. Person under a protective order or other court-order will not be allowed to visit without a letter from the issuing court.
4. Persons who are currently on Probation or Parole may not visit without a letter from their supervising officer.
5. Inmates shall be allowed two (2) twenty (20) minute visit in person non-contact visits per week. The visit starts at the time the visitor(s) and inmate are in the visiting room. Any portion of a visit will count as a 20-minute visit. At least one

visitation period will be allowed during evenings or weekends.

6. Visitation days for Male inmates are Monday, Wednesday, Friday, and Saturday during posted times. Visitation days for Female inmates are Monday, Wednesday, Friday, and Saturday during posted times. Visitation times shall be 8 am-11 am morning or 2 pm-5 pm afternoon. Morning visitation and afternoon visitation will rotate equally with the schedule times posted on the website or in the lobby monthly.
7. If at any time this facility has more female inmates than this schedule can accommodate, the schedule will be changed to handle more visits.
8. Public visits will be conducted in the visitation room only.
9. Inmates will not be allowed to have contact visits with anyone other than attorneys or clergy.
10. Attorneys and clergymen wishing to visit inmates are asked to schedule visits between the hours of 8:00 a.m. and 5:00 p.m. If the visits cannot be done between these hours, arrangements will be made so they may visit.
11. Special visitation may be approved by the Sheriff in case of emergency.
12. Visitors will not be allowed to carry any items into the jail (cell phones, purses, packages, sacks, books, food, beverages, etc....). Visitors who violate this rule will be asked

to leave and may be denied visitation for a period of 30 days.

13. Visitors who bring or attempt to introduce contraband into the jail may be permanently denied visitation in the Comanche County Jail and may be subject to criminal prosecution.
14. Vulgar language and/or gestures will not be tolerated, and visits may be terminated.
15. Sheriff Office personnel can deny or suspend visitation privileges for violation of these rules. Denial can be appealed to the Sheriff. The decision of the Sheriff is final.
16. Upon presentation of proper documentation an inmate's guardian may have in-person non-contact visitation for a reasonable amount of time in addition to normal documented visitations. Proper documentation is provided for in Section 1002.012, 1106.001 and 1106.003 Texas Estates Code.
